<p><b>Employment, office, trade, profession, or vocation</b> Any employment, office, trade, profession, or vocation carried on for profit or gain.</p>		
<p><b>Sponsorship</b> Any payment or provision of any other financial benefit (other than from the council) made to you as a councillor during the previous 12-month period for expenses incurred by you in carrying out your duties as a councillor, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>

<p><b>Contracts</b></p> <p>Any contract made between you as a councillor or your spouse or civil partner or the person with whom you as a councillor are living with as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director* or a body that such person has a beneficial interest in the securities of*) and the council -</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>		
<p><b>Land and Property</b></p> <p>Any beneficial interest in land which is within the area of the council.</p> <p>'Land' excludes an easement, servitude, interest or right in or over land which does not give you as a councillor or your spouse or civil partner or the person with whom you as a councillor are living as if they were spouses / civil partners (alone or jointly with another) a right to occupy or to receive income.</p>	<p>9 Newlands Court Heath Hayes Cannock WS12 3YS</p>	<p>9 Newlands Court Heath Hayes Cannock WS12 3YS</p>
<p><b>Licences</b></p> <p>Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer.</p>

<p><b>Corporate tenancies</b></p> <p>Any tenancy where (to your knowledge as a councillor)-</p> <p>(a) the landlord is the council, and</p> <p>(b) the tenant is a body that you, as a councillor, or your spouse or civil partner or the person with whom you as a councillor are living as if they were spouses / civil partners is a partner of or a director* of or has a beneficial interest in the securities* of.</p>		
<p><b>Securities</b></p> <p>Any beneficial interest in securities* of a body where -</p> <p>(a) that body to your knowledge as a councillor, has a place of business or land in the area of the council, and</p> <p>(b) either -</p> <p>(i) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body, or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you as a councillor, or your spouse or civil partner or the person with whom you as a councillor are living as if they were spouses / civil partners have a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>		

*\*\*director' includes a member of the committee of management of an industrial and provident society.*

*\*\*securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.*

You must register as an 'Other Registerable Interest' any of the following:

Area of Interest	Nature of Interest
(a) Any unpaid directorships	
(b) Any body of which you are a member or in a position of general control or management and to which you have been appointed or nominated by your authority.	
(c) Any body exercising functions of a public nature, of which you are a member or in a position of general control or management.	
(d) Any body directed to charitable purposes, of which you are a member or in a position of general control or management.	
(e) Any body whose principal purposes include the influence of public opinion or policy (including any political party or trade union), of which you are a member or in a position of general control or management.
