<p>Contracts</p> <p>Any contract made between you as a councillor or your spouse or civil partner or the person with whom you as a councillor are living with as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director* or a body that such person has a beneficial interest in the securities of*) and the council -</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>

<p>Licences</p> <p>Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer.</p>

<p>Corporate tenancies</p> <p>Any tenancy where (to your knowledge as a councillor)-</p> <ul style="list-style-type: none"> (a) the landlord is the council, and (b) the tenant is a body that you, as a councillor, or your spouse or civil partner or the person with whom you as a councillor are living as if they were spouses / civil partners is a partner* of or a director* of or has a beneficial interest in the securities* of. 		
<p>Securities</p> <p>Any beneficial interest in securities* of a body where -</p> <ul style="list-style-type: none"> (a) that body to your knowledge as a councillor, has a place of business or land in the area of the council, and (b) either - <ul style="list-style-type: none"> (i) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body, or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you as a councillor, or your spouse or civil partner or the person with whom you as a councillor are living as if they were spouses / civil partners have a beneficial interest exceeds one hundredth of the total issued share capital of that class. 		

**'director' includes a member of the committee of management of an industrial and provident society.*

**'securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.*
