

I am against the proposed plans to develop the land on the site off the Wimblebury Road and Cannock Road in Wimblebury and Heath Hayes.

There are several reasons why I would state that the land is unsuitable for development. This is greenbelt land which boarders the village of Wimblebury and Heath Hayes and as stated in Objective 7 of the Local Plan that the Landscape Character 'Protecting, conserving and enhancing the Cannock Chase National Landscape, as required by Policy SO7.5 and the Green Belt (as required by Policy SO7.6)'. By building on this lad this is NOT being adhered to as this will live little greenbelt land so is NOT legally compliant.

The area has already been extensively developed over that last 30 or so years and as such additional development is going to struggle on an already fragile infrastructure.

Recent statistics for Cannock Chase (Staffordshire.gov) show that the population is 6 times that of neighbouring Stafford District and 4 times that of Lichfield District.

It is not feasible that our local area becomes the over spill for West Midlands districts.

The Greenbelt land that is part of the development plan is home to wildlife, this includes deer's that are regularly seen in this area and we are talking large numbers of deer's where are they going to go if we destroy their home, they were here long before us and we have already developed on their land we need to save what is left for them and other animals.

The site is to be built opposite a local primary school where there is already significant traffic congestion so bringing more traffic to the area would be catastrophic. The proposed relief road that goes round the back of the allotments and park to join the Cannock Road will massively increase the heavy congestion not to mention the pollution levels of more cars in the area.

The land in question will have a massive impact on our villages, in fact they will no longer be villages as the population will be so high, we do not have the hospitals, GP's, Dentists, Schools, or shops to be able to facilitate this development. There has been a lot of development in and around Cannock recently and this is impacting everywhere.

The proposal is ludicrous and should not be agreed by our council. (Please continue on a separate sheet if necessary)
