**CANNOCK CHASE DISTRICT COUNCIL
NEW LOCAL PLAN 2026 – 2046 CALL FOR SITES**

Cannock Chase Council commenced works on a new Local Plan on 26 June 2026 under the new plan-making system. As part of the preparation of its new local plan for Cannock Chase, the Council is running a Call for Sites outside of the scope of the usual process which is open all year round.

This is an opportunity for landowners, site promoters, developers or other interested parties to put sites forward for consideration in the new local plan to meet future needs of the area. Alongside the submission of new sites, we are requesting any updates to information on existing sites within the SHLAA and/or ELAA inclusive of sites allocated within the Local Plan 2018 – 2040. The SHLAA and ELAA will continue to inform and contribute to the evidence base for the Council's Local Plan documents, Brownfield Register and the Authority Monitoring Report (AMR).

If your site is currently allocated within the Local Plan 2018 – 2040 it is still required for a site update to be provided via the Call for Sites to ensure availability and deliverability of the site is confirmed.

Any existing sites within the SHLAA and ELAA will be reviewed as part of the site selection process, if you wish for your site to remain in the SHLAA and/or ELAA and be considered as an option for development within the New Local Plan please confirm this via this Call for Sites. If the Council does not receive a response, it may be assumed that the site is no longer being promoted for development and is therefore no longer 'available'.
